We have a part-time counselor, a psychologist and a part-time nurse. The Geyserville Educational Foundation and Parent Club are an active body of parent volunteers who through fund raising activities and grant opportunities, fund music, art, science, dance and garden enrichment for all students. They also provide financial support to classrooms for special projects, programs, field trips, and technology upgrades district wide. Geyserville Elementary School is part of an active district bilingual advisory council, which gives input in regards to our English Language program and District EL Master Plan. Parents serve as volunteers in classrooms, special events, field trips, and provide general assistance as needed. In addition, Geyserville Elementary School has an after-school program operated by the Boy's and Girl's Club.
